NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Legal (State and Subordinate) Service Rules, 1981, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Legal (State and Subordinate) Service (Amendment) Rules, 2012.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of Schedule I.- In Schedule I appended to the Rajasthan Legal (State and Subordinate) Service Rules, 1981, hereinafter referred to as the said rules,-

- (i) in column number 5 against serial number 3, for the existing expression "Head Legal Assistant", the expression "Senior Legal Officer" shall be substituted.
- (ii) in column number 2 against serial number 4, for the existing expression "Head Legal Assistant", the expression "Senior Legal Officer" shall be substituted.
- (iii) in column number 5 against serial number 4, for the existing expression "Legal Assistant", the expression "Junior Legal Officer" shall be substituted.
- (iv) in column number 2 against serial number 5, for the existing expression "Legal Assistant", the expression "Junior Legal Officer" shall be substituted.

3. Amendment of Schedule II.- In Schedule II appended to the said rules, in title, for the existing expression "LEGAL ASSISTANT", the expression "JUNIOR LEGAL OFFICER" shall be substituted.
